January 12, 2015

1. The meeting was called to order by Mayor Daryl Behrends.
2. Members present: Mayor Daryl Behrends; Council Members: Don Buys, LeRoy Buys, Faye Schuur; City Clerk: Kris Gunnink; City Maintenance/Waste Water Supervisor: Jeff Gunnink; Fire Chief: Dan Gunnink; Guest: Bob Prins.
3. Pledge of Allegiance to the Flag.
