Council Minutes
September 14, 2015

- 1) The meeting was called to order by Mayor Daryl Behrends.
- 2) Members Present: Mayor Daryl Behrends, Council members; Don Buys, LeRoy Buys, Bob Prins and Faye Schuur; Clerk, Kris Gunnink; Public Works; Jeff Gunnink: County Commissioners; Gerald Magnus and Glenn Kluis: Guests; John and Caryl Busman.
- 3) Pledge of Allegiance to the Flag.
- 4) Faye Schuur moved to approve the minutes of the August 10, 2015 Council Meeting. Bob Prins seconded the motion to accept the minutes. Motion carried.
- 5) Bob Prins moved and Don Buys seconded the motion to approve the Financial Reports for the City and Fire Departments. Motion Carried.
- 6) John and Caryl Busman addressed County Commissioner Magnus and Kluis if Murray County is looking into Broadband improvements for the county. The County at looked into it, but at this point it is very expensive to do at this time.
- 7) City Council and County Commissioners took a walk and inspected the retaining wall (that was built by Murray County) located along 5th Street. This is a county road and the sidewalk and retaining wall are in disrepair. City Council also asked to Commissioners to inspect the waterway on Hwy 91. It is filled with debris and drainage is slow through the culvert.
- 8) Gerald Magnus and Glenn Kluis reported what the Murray County Commissioners are working on. The County Courthouse is getting a new roof, working on safety issues within the courthouse for Judges, new buffer zones on ditches/waterways rules, 2016 Budget, and overall structure of County jobs.
- 9) LeRoy Buys moved and Faye Schuur seconded the motion to approve a building permit for Bob Prins to install brick and make improvements to his home. Motion carried.
- 10) Council was presented 2016 proposed Budget. Don Buys moved to set a preliminary general tax levy for 2016 at 10 percent increase. Bob Prins seconded the motion. Motion carried.
- 11) Faye Schuur made a motion to transfer \$5000.00 from Water Fund into Capital Outlay Savings for future repairs to the water tower. Bob Prins seconded the motion. Motion carried.
- 12) Faye Schuur moved to pay annual League of MN Cities dues and the MN Mayor dues. Bob Prins seconded the motion. Motion Carried.
- 13) Bob Prins moved to purchase a new DO and pH tester for the waste water system with an estimated cost of \$700.00. Don Buys seconded the motion. Motion carried.

- 14) The clerk will send a compliance letter (as per City of Chandler Ordinances) to the residents in Chandler with junk vehicles.
- 15) The clerk will update the City Cell Phone and Usage plans.
- 16) LeRoy Buys moved and Bob Prins seconded the purchase of 2 new office chairs for the clerk office. Motion carried.
- 17) LeRoy Buys moved to have Fuller Paving finish the repair of 2nd Street and other streets with potholes. Faye Schuur seconded the motion. Motion carried.
