

**City of Chandler  
Council Minutes  
March 14, 2016  
7:00 pm**

- 1) The meeting was called to order by Mayor Daryl Behrends.
- 2) Members Present: Mayor Daryl Behrends, Council members; Don Buys, LeRoy Buys, Bob Prins and Faye Schuur; Clerk, Kris Gunnink. Water/Waste Water Operator, Jeff Gunnink; Fire Chief, Dan Gunnink; Guests, Ed and Lisa Braun.
- 3) Pledge of Allegiance to the Flag.
- 4) Faye Schuur moved to approve the minutes of the February 8, 2016 Council Meeting and February 22, 2016 Annual Fire Contract Meeting. Don Buys seconded the motion to accept both meeting minutes. Motion carried.
- 5) Faye Schuur moved and Bob Prins seconded the motion to approve the Financial Reports for the City and Fire Departments. Motion Carried.
- 6) Don Buys moved to approve Ed and Lisa Braun's building permit at 831 Valley View Avenue with a condition of applying for a deed restriction on the 2 lots that they own and plan to build a shed over the lot line. Bob Prins seconded the motion. Motion carried. The deed restriction will be the property owner's expense.
- 7) The building permit for 300 Ryan Ave has been tabled until the next meeting as the council is requesting more information in regards to building placement and property accessibility with a garage addition to the property.
- 8) Clerk Correspondence:

- 9) LeRoy Buys made a motion to accept Bo Ilse application to the Chandler Fire Department. Faye Schuur seconded the motion. Motion carried.
- 10) LeRoy Buys made a motion to approve that the Chandler Fire Department have the Lake Wilson Fire Department respond to Chandler rural fire calls with their water truck. This will improve the ISO Rating/insurance for both Departments. Don Buys seconded the motion. Motion carried.
- 11) Dan Gunnink, Fire Chief, discussed with the City Council that Heiman Fire Equipment inspected the turnout gear for our Firemen and most of the gear has expired and should be replaced. Dan will look into getting another opinion from another company any report back to the City Council.
- 12) Faye Schuur discussed the Red Cross Home Fire Campaign Overview. The date is set for Saturday, May 14, 2016. More information will be made to the public through signs and in the utility billing in May.

- 13) Bob Prins made a motion to transfer the Monogram Meats SIU agreement excess charges into the Waste Water saving account. LeRoy seconded the motion. Motion carried.
- 14) City Council discussed the SIU Agreement overages that Monogram Meats has had. The City of Chandler Waste Water Operator has had a meeting with Lynn Buldhaupt in regards to having Monogram back into compliance with SIU agreement. It will be expected to have an odor in town this spring.

- 16) City Council reviewed the City Maintenance/Waste Water Operator wages. LeRoy Buys made a motion to increase the salary by 3%. Don Buys seconded the motion. Motion carried.
- 17) City clerk will have the League of MN Cities review a contract with Geromino Energy.
- 18) Bob Prins moved to accept concept minutes. Don Buys seconded the motion. Motion carried.
