

**City of Chandler
Council Minutes
June 12, 2017
7:00 pm**

- 1) The meeting was called to order by Mayor Daryl Behrends.
- 2) Members and Guests Present: Mayor; Daryl Behrends, Council members; Alan VanDam, Faye Schuur, Robert Prins and LeRoy Buys; Clerk, Kris Gunnink; City Maintenance/Waste Water Supervisor, Jeff Gunnink. Guest, Dave Holm.
- 3) Pledge of Allegiance to the Flag.
- 4) Mayor Daryl Behrends opened the meeting with prayer.
- 5) LeRoy Buys moved to approve the Minutes of the May 8, 2017 City Council Meeting. Seconded by Bob Prins. Motion carried.

- 11) City clerk read a letter from Doran and Jean Christoffels regarding the painting of the retaining wall on the north end of 4th street. City council gave permission to go forward with their plan to paint the wall.
- 12) The City maintenance will continue to mow by the Frontier building and EDA building (old bank). City council advised clerk to send an annual bill for mowing each property.
- 13) City clerk will work on a utility billing policy and procedure. Mainly focusing on past due water and sewer bills.
- 14) Clerk will send out an ordinance violation letter in regards to chickens in city limits.
- 15) Bob Prins made a motion to install hand rails at the community center to assist with the steps to the stage. Alan VanDam seconded the motion. Motion carried.
